Academic Integrity - Policy on Conflict of Interest (as per minutes of 10Oct06)

Notice of motion is given by K. Whetter and John Eustace as follows:

Whereas according to *The Constitution and By-Laws of the Senate of Acadia University* and *An Act Respecting Acadia University*, "The Senate is responsible for the educational policy of the University" and "has power"

- (a) to consider and, if thought fit, to approve the recommendations of the Faculty of the University with regard to the curricula of Acadia university and its affiliated institutions:
- (b) to determine, regulate and control the educational policy of the University;
- (c) to determine the courses of study and standards of admission to the university, and continued membership therein, and qualifications for degrees and diplomas
- (d) to conduct examinations and appoint examiners;
- (e) to deal with all matters arising with the award of fellowships, scholarships, bursaries, medals, prizes and other awards
- (f) to confer the degrees of Bachelor, Master, and Doctor, and all other degrees and diplomas in all branches of learning that may appropriately be conferred by a university;

Whereas in *An Act Respecting Acadia University*, the Registrar is fundamentally an officer of Senate and the Executive Committee of Senate as a non-voting Secretary;

Whereas the Registrar's office is the operational arm of Senate, responsible for ensuring that the academic regulations constituted by Senate are enacted in a way consistent with Senate's determinations;

Whereas the Registrar's office should report to the Vice-President Academic, who is charged with administrating academic issues at Acadia;

Whereas the Student Affairs office has no standing on academic matters of the University in either *The Constitution and By-Laws of the Senate of Acadia University* or *An Act Respecting Acadia University*;

And whereas the translocation of the Registrar's Office to Students Affairs was done without Senate's authority or approval;

Senate directs the President to restore the Registrar's Office to the Office of the Vice-President Academic, and directs the President to bring all such changes to the educational and academic structure of the University before Senate as per the legal prescriptions of *An Act Respecting Acadia University*.

Moreover, whereas part of the reasoning for moving the Registrar's Office includes the idea that it be reunited with Admissions, Senate also directs the President to return Admissions to the office of the Registrar.

The Senate Nominating Committee has completed its work in bringing forth the nominations for the *ad hoc* Committee on Need Based Financial Assistance for Students. The Committee brings to Senate the following nominations:

- one Senator from each faculty:
 - o Faculty of Arts Gordon Callon
 - o Faculty of Professional Studies Ron Lehr
 - o Faculty of Pure and Applied Science Ian Spooner
- two student Senators, to be appointed by the SRC
 - o Peter Eirikson
 - Kate Robinson
- the Coordinator of Scholarships, Awards, and Financial Assistance Scott Robinson

The mandate of the Committee is:

- to review the two bursary programs that are currently operating;
- to make recommendations to Senate regarding modifications to the programs with the goal of increased student awareness and improved service delivery; and
- to recommend an appropriate mechanism through which Senate can exercise its continuing responsibility for oversight in the bursary award process.
