Notice of Motion to Senate for May 2007 Meeting

Motion:

That the designation "(non-voting)" be removed from the line in the list of membership (*Constitution and By-Laws*, section II) that currently reads, "A member of the Faculty of Theology (non-voting)."

Net Result:

This does not increase the number of persons at the University Senate, but simply grants voting privileges to one member who comes regularly from the Faculty of Theology. The net result, if passed, is that the Faculty of Theology would have two votes instead of one at the University Senate.

Rationale:

Since the Faculty of Theology, also known as the Acadia Divinity College to its external constituency, is a legal faculty at Acadia University and by act of Incorporation and approval by both the Board of Governors of Acadia University and the Board of Trustees for the Acadia Divinity College, it is appropriate and necessary to have more than one vote at Acadia Senate meetings. Presently, while the Dean of the Faculty of Theology can make a motion, there is no one else from that faculty who can second it. Since all of our programs of study and courses are approved by the University Senate, and all of our degrees are awarded by the University upon approval by the University Senate, it is appropriate that the Faculty of Theology have more representation not only on the Senate's committees as has been proposed, but also in the meetings of the whole Senate. The Deans of the other three faculties each have a vote, but each faculty of the University, except the Faculty of Theology, has nine faculty representatives on the Senate. The Faculty of Theology has one faculty representative who cannot make motions, second motions, or vote on them before the Senate. It is time to correct this inequity and grant two votes to the Faculty of Theology.

While the other faculties are indeed larger in numbers of students, they are in no way nine times larger than the Faculty of Theology and they are also not the same size in enrollment, so if the allotments are to be meted out by proportions, as was earlier suggested, it seems that adjustments should be made regularly depending on the size of enrollment in each of the faculties. Also, while it is true that the Faculty of Theology is smaller than some departments (we have approximately 160 full and part-time students), it is still a faculty and therefore needs adequate representation to conduct its business at these meetings. We are only asking for due consideration for another voting member at these meetings. Thank you for your consideration.

Duties:

"The duties of the Executive Committee shall be as follows: between meetings of Senate, to consider matters that in its judgement call for senatorial action or that by statute law may require senatorial action; to consider matters referred to it by Senate" (*Constitution and By-Laws* VII).

"Under unusual circumstances the Executive Committee may cancel regular monthly meetings. It may not cancel two such meetings in succession" (*Constitution and By-Laws* IV.1c).

Summary of Activities:

The Executive became more active this year. Besides performing its usual activity of receiving agendas for comment via e-mail prior to Senate meetings, it held a meeting on Dec. 18, and plans another in the near future.

The purpose of these meetings is to discuss potential planning issues, with a view to identifying those issues which will need to come before Senate. The purpose is also to arrive at some consensus on *how* they should come before Senate (for example, whether they should come through a standing committee, a special committee, or directly onto the floor of Senate itself).

Comment:

With this sort of procedure in place, the Executive can help clarify the ongoing role of Senate as a governance body. In particular, it can constructively discuss the role of Senate in determining educational policy.
